- AND WHEREAS, the recognition was granted by NRC to Govt. Post Graduate College, Lower Lakhwar Colony, Dak Pathar, Vikas Nagar, District - Dehradun, State- Uttarakhand for B.Ed. Course vide order No.F.NRC/NCTE/UR-146/2008/67155-61 dated 23.12.2008 with an annual intake of 100 seats with effect from the academic session 2008-09.

 - (c) Names of students admitted during the current session along with qualification, Percentage of (d) marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - Fee charged from students. (e)
